



Modern Knowledge Schools Student User Agreement

Effective Date: January 1, 2026

Welcome to Modern Knowledge Schools ("MKS"). This Student User Agreement ("Agreement") outlines the terms and conditions for the use of electronic devices, software, and communication tools provided by MKS. By utilizing MKS's services, you acknowledge that you have read, understood, and agree to be bound by the terms and conditions set forth in this Agreement.

1. ACCEPTANCE OF TERMS

By enrolling at Modern Knowledge Schools and accessing our services, you agree to comply with and be bound by the following terms.

2. DEVICE REQUIREMENTS

- a. Grades 1 to 5: Students in Grades 1 to 5 are required to use licensed iPads only for educational purposes.
- b. Grades 6 to 10: Students in Grades 6 to 10 are required to use licensed Chromebooks only for educational purposes.
- c. Grades 11 to 12: Students in Grades 11 to 12 may use licensed Chromebooks, Windows laptops, or MacBooks only for educational purposes.

Note: All devices are purchased and owned by the students.

3. RESPONSIBLE USE

- a. Users must use the authorized electronic devices exclusively for educational purposes as directed by MKS faculty and staff.
- b. Students are responsible for the physical security and proper care of their personally owned devices, ensuring they are kept in good working order.



c. Any damages or loss must be promptly reported to the school IT Department by the respective device owner.

4. SOFTWARE AND APPLICATIONS

a. Users are permitted to install only approved software and applications as directed by MKS faculty and staff.

b. Unauthorized installation, downloading, or sharing of any software or applications is strictly prohibited.

c. Students are responsible for keeping their devices, software and applications up-to-date in accordance with school guidelines.

5. DATA AND PRIVACY

a. Users are expected to respect the privacy of others and not attempt to access, modify, or delete data belonging to fellow students, faculty, or staff.

b. MKS reserves the right to monitor and access user accounts, communications, and data stored on student-owned devices for administrative and educational purposes.

c. Students are encouraged to back up important data regularly, and MKS shall not be held responsible for any loss of data.

6. CODE OF CONDUCT

a. Users must adhere to MKS's Code of Conduct, both online and offline, and treat all members of the school community with respect.

b. Bullying, harassment, or any form of disruptive behavior is strictly prohibited.

c. The use of electronic devices for non-educational activities during class time is not permitted, and students are expected to follow teacher instructions regarding device usage.
